 - viii. The Ilm Foundation, before its large-scale printing and supply to schools, will ensure that the textbooks are free from all grammatical/punctuation/logical errors.
 - ix. There is no violation of copyrights laws in use of content including illustrations and tables etc. in development of these textbooks.
